Community Service Program

This Release and Indemnification Agreement is made and given to the City of Glenpool, Oklahoma, a Municipal Corporation.

The undersigned defendant has entered a plea of guilty or nolo contendere and has been placed on probation with the Glenpool Municipal Court.

In lieu of fine and/or costs, and/or as consideration for dismissal or reduction of a violation, the undersigned defendant hereby releases, indemnifies and holds harmless the City of Glenpool, Oklahoma, for any injury or event suffered by the undersigned defendant directly or indirectly arising out of duties which he/she may perform for the City of Glenpool or its subsidiaries or any of its beneficiary trusts, or for any other public or private agency without limitation, while fulfilling any obligation to the City of Glenpool, Oklahoma.

The undersigned defendant represents that he/she is 18 years of age or older or, in the event the undersigned defendant is under 18 years of age, a parent, guardian or next of kin of the undersigned defendant, by execution and endorsement of this agreement, acknowledges that the City of Glenpool shall not be responsible for any injury to person or property which may be sustained by the minor during the course of fulfilling any obligation to the City of Glenpool, and further, for and on behalf of the minor as such parent, guardian or next-of-kin indemnifies, saves and holds harmless the City from injury to persons or property.

GLENPOOL MUNICIPAL COURT Community Service Program

Our community service program was initiated primarily for juveniles who are first time offenders. The number of hours the defendant is to perform is set by the Court based upon the seriousness of the offense, the defendant's prior record and defendant's attitude. Upon the completion of the defendant's work hours, and any other conditions imposed by the Court, the Judge will dismiss or reduce the charge as agreed.

It is **YOUR RESPONSIBILITY** to find the time and location to perform the community service that the Glenpool Municipal Court has assigned. If you choose more than one **NON-PROFIT** organization to complete the community service hours ordered, you must have a letter (as described below) from each organization.

1. You must perform the community service at a **pre-approved NON-PROFIT** organization. A list of pre-approved organizations is attached. If you choose a **NON-PROFIT** organization that is not on the list you are required to get **PRE-APPROVAL** from the Court Clerk's office. YOU will need to contact the organization to make arrangements to perform your community service there.
2. You **MUST** perform the assigned community service hours **before** your review date. *Failure to provide the Court with proof of completion of your assigned hours by the review date may result in a suspension of your driver's license and/or revocation of your probation, which may result in conviction of the original charge. Only the documentation described in paragraph 5, signed by a duly authorized representative of the organization for which you perform community service, will satisfy the proof of completion requirement.*
3. You are to report for work as agreed with the supervisor of the organization. You must call the supervisor if an emergency prevents you from reporting for work.
4. **The supervisor is to write a statement on company or agency letterhead stating the number of hours you worked for the company or agency, duties performed, your attitude while working, and any additional comments that they may have. You are to provide this letter on your review date.**
5. You are to write an essay describing how your work benefited the community & yourself. This is to be **TYPED** with a **minimum of 500 words**. You are to provide this on your review date along with the supervisor's statement.

REMEMBER, IT IS UP TO THE DEFENDANT TO COMPLETE HIS/HER HOURS IN THE ALLOTTED TIME. DO NOT WAIT UNTIL THE LAST MINUTE TO SCHEDULE YOUR HOURS.
