Executive Summary

Mayor and Council,

First, let me say congratulations to Chris Brobst, who won his election this past week and will retain his seat for a new four-year term. I would also like to congratulate Tim Fox on a new four-year term and Shayne Buchanan, on successfully being chosen to fill the last two years of the open At-Large seat. All three council members will be sworn in at the April 21st Council meeting. While I was disappointed in the low voter turnout, I am thankful for all of the residents that took time to go to the polls and let their voices be heard. I am a firm believer, as I know all of you are as well, in the power of the public voice to guide us as we continue our efforts to grow and effectively manage this community. This vote, combined with the recent Glenpool Public Schools bond vote, is indicative of the support we enjoy in Glenpool, from the professional employees across the organization to the amazing job you as the Council do to lead and guide us. I am encouraged and delighted at the wonderful future this city has in front of it.

As you review the following departmental reports, I hope you take notice of the number of different projects that have been completed or are in progress. Allow me to take a moment and highlight a few that are in the report and add a few others that I believe are informative.

- Pictured on the cover this month is the entrance to our recent Community Cleanup event that was held at the high school football field parking lot. Thank you to Glenpool schools for continuing to allow us to use your facility for these great events! We had a large turnout from the public that led to a few problems with the clean out and turnaround of the dumpsters, but our team did an amazing job of staying on top of things and the public was understanding and patient.
- During the recent wildfire outbreak across the state, our fire crews were instrumental in putting out several fires in Glenpool before they could get out of hand. They also spent time in Jenks, Mounds and in Osage county assisting with other fires during this breakout.
- The Hwy 75 Project continues to progress at a steady pace. We will continue to see traffic delays and construction-related heartburn throughout the project, but thankfully ODOT and the contractor have been responsive to our needs and requests. The much-anticipated closure of the center median at 146th has finally occurred. We had a few issues the first week or two after the closure, but commuters have adjusted, and the traffic pattern has settled back into place.
- On the topic of road maintenance, our Streets Crew just completed the repairs to the bridge decking for the 126th St. bridge. This was the first time our crew had attempted this level of repair, and they did a tremendous job. I want to give a huge shoutout to County Commissioner Kelly Dunkerley and his district superintendent. The superintendent was



onsite for the project and helped train our crew. I am very thankful for the partnerships we have created with the county and other governmental organizations in the area.

- One final note on road maintenance...I anticipate that staff will be going out to bid this month on our annual road repair projects. We anticipate having those bids ready in time to be awarded in June with
- The disc golf course clearing and preparation is underway for opening later this spring or early summer. I expect to have potential course names submitted to Council soon for your consideration. We have had a great response from the Tulsa area disc golf association and other business partners who have sent volunteers regularly to help prepare this course.
- Our Finance Staff and Executive Team have been working diligently on the annual budget for the upcoming fiscal year. We are excited to present the first draft this month and hear from the Council and the public regarding the priorities for next fiscal year.
- Sales tax last month was up 7.2% across all funds.
- This month's report also includes our quarterly Move Glenpool Forward update. The Leadership Team has been working with our City Engineer and Public Works Director to prioritize and update budget numbers for all the remaining streets and infrastructure projects. I anticipate we will be presenting this information in the next month or two.
- The Glenpool Conference Center hosted an Emerging Leaders class that was led by the City Managers Association of Oklahoma. This class is designed to identify and train municipal leaders from across the state.
- Lea Ann Reed attended OML's Community Leadership Class with Mayor Calvert in Alva recently. This is the third in a series of ongoing classes for this program.

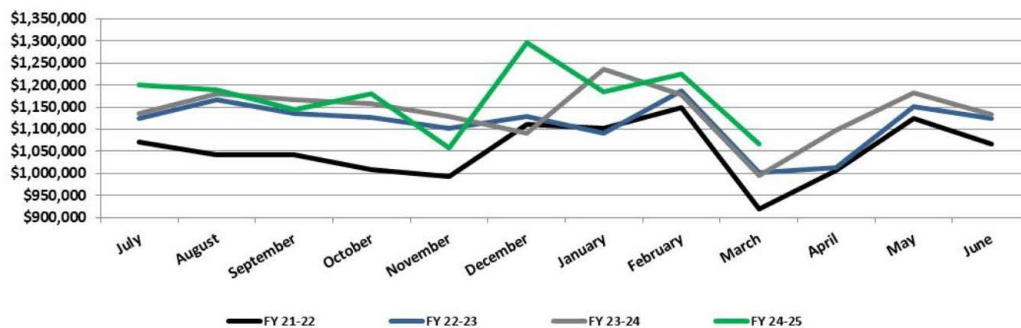

FY 24-25 Combined Sales Tax for all funds in March totaled \$1,065,806, 7.2% higher than FY 23-24 revenues for the same period. Further details on March financial results will be reported next month after the accounting period is closed.

GENERAL FUND REVENUES

FY 24-25 General Fund revenues through February totaled \$11,277,267 which is \$249,038, or 2.3%, higher than FY 23-24 revenues for the same period. Year-to-date revenues are \$336,251 above budget., with Sales Tax, Investment Income, Intergovernmental, and Miscellaneous revenues all up.



GENERAL FUND EXPENDITURES

FY 24-25 General Fund expenditures through February totaled \$10,233,675, or \$180,327 (1.8%) higher than FY 23-24 expenditures through the same period. These expenditures were 9.9% under budget year-to-date.

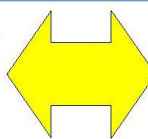

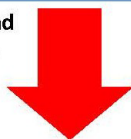

SALES TAX REVENUES—ALL FUNDS



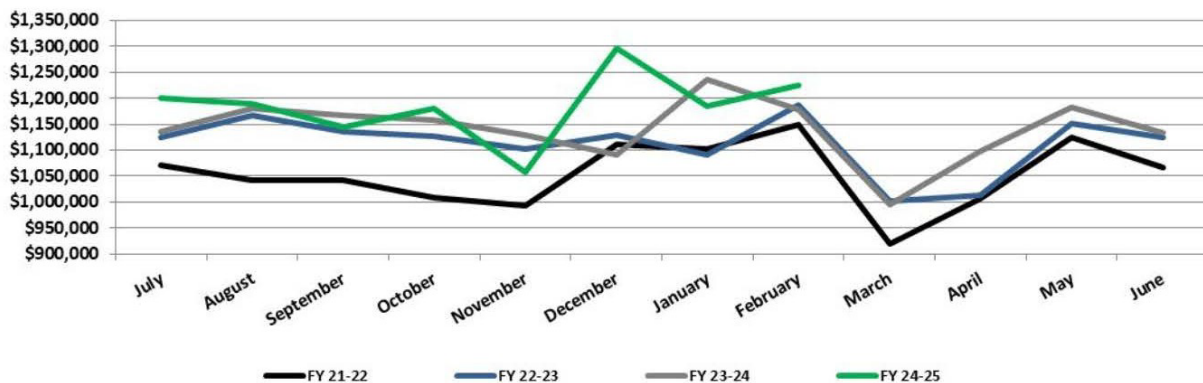

FY 24-25 Actual Compared to Previous 3 Fiscal Years Actual

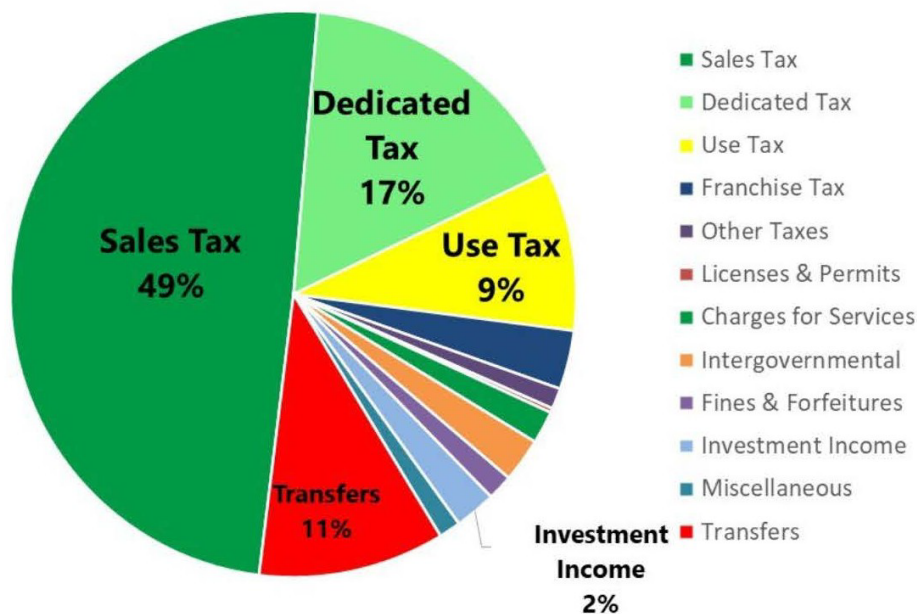

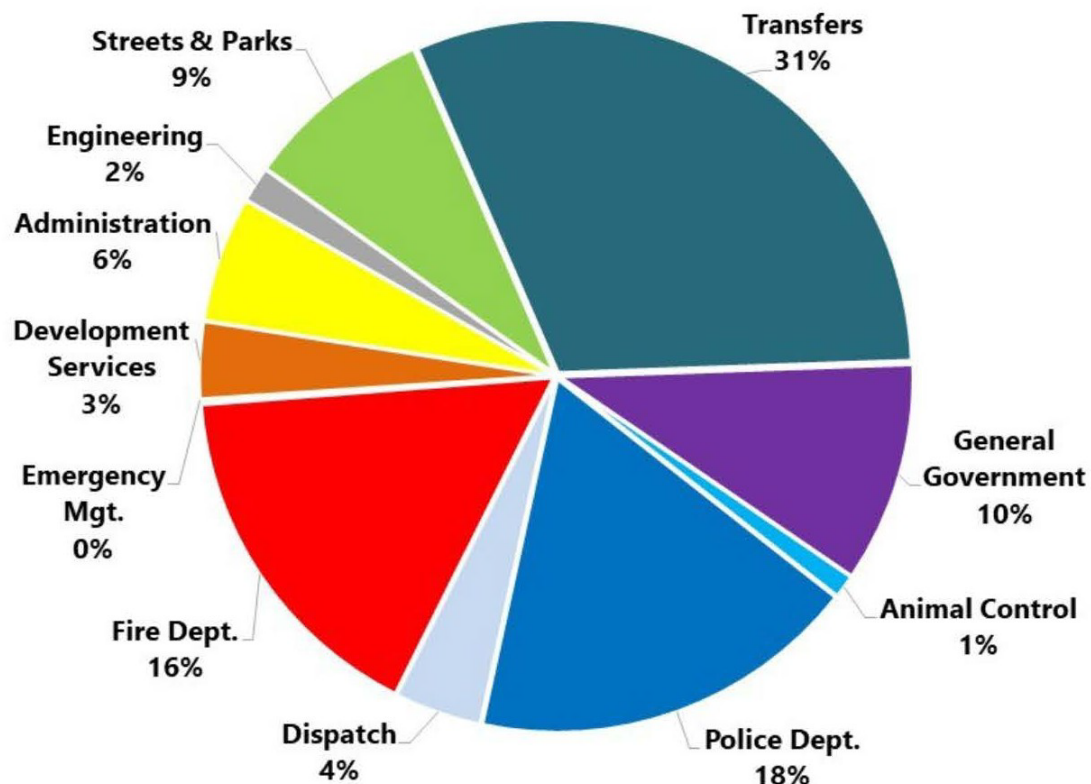

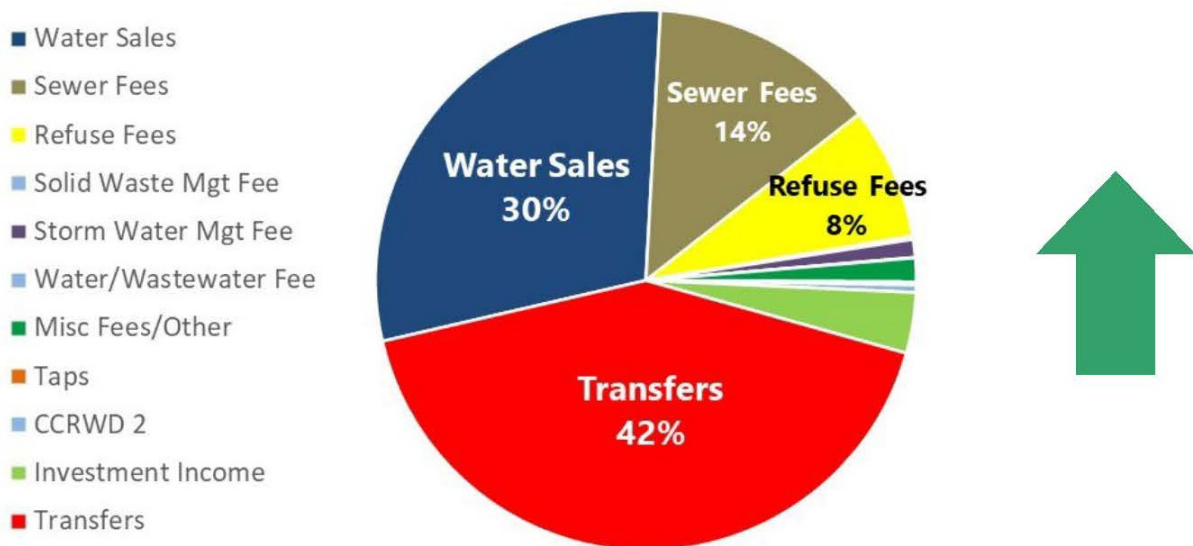

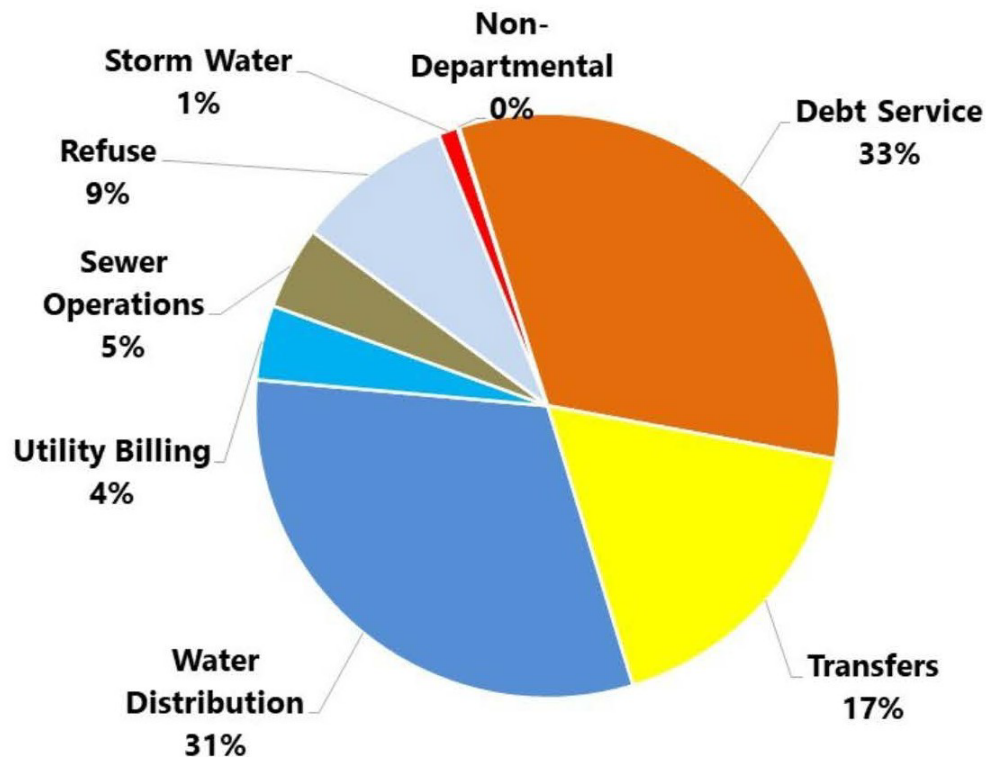

Disc Golf Course - UPDATE

Each tee pad received as a base and all were compacted by staff. Play will commence with a small group to make sure natural growth doesn't undo all the clearing we have done. The goal now is for a June 1 grand opening. This is subject to change.



GlenPines Sewer Encasement at Zenith



Within the Glen Pines subdivision there is a storm water area that had a sanitary sewer line spanning over the runoff area. This free floating PVC pipe was very susceptible to rupture due to it's free span across the storm water discharge area. Quotes are received and a vendor was selected to secure the area.



The existing pipe was cut and the new pipe was secure within a casing pipe, which was then secured by concrete on either bank. Further more the bed was secured with rip rap to reduce erosion.



Elwood Lift Station - Bypass

A bypass was originally installed at this station but some years ago the bypass pipe cracked and was removed. Elwood is a crucial lift station that receives more than its fair share of flow so adding back the bypass to this station was on the list of repairs to complete this year.

If the station pumps fail, the wet well will fill and eventually overflow a manhole to the north of the station.

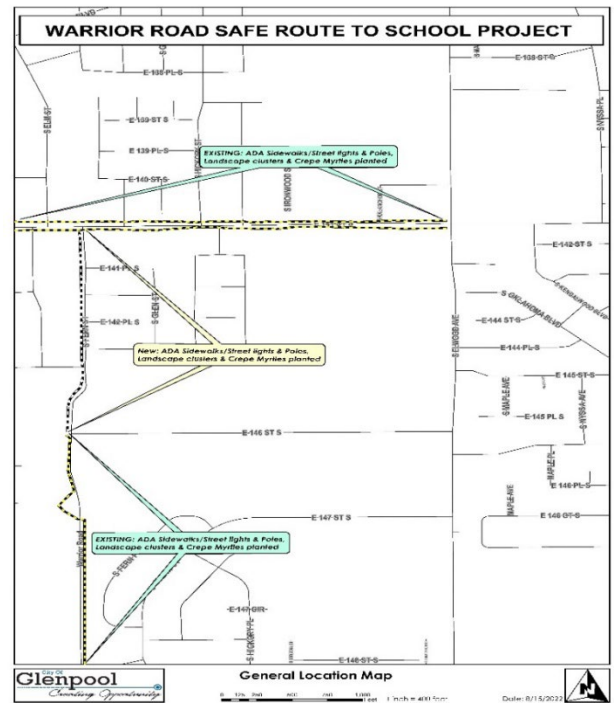


Contractors installed a much needed bypass valve. This allows for a bypass pump to be used if there is an issue with the onsite pumps or if there is an electrical outage.

TAP Grant Sidewalk Improvement Project on Warrior Road. JP#3802804

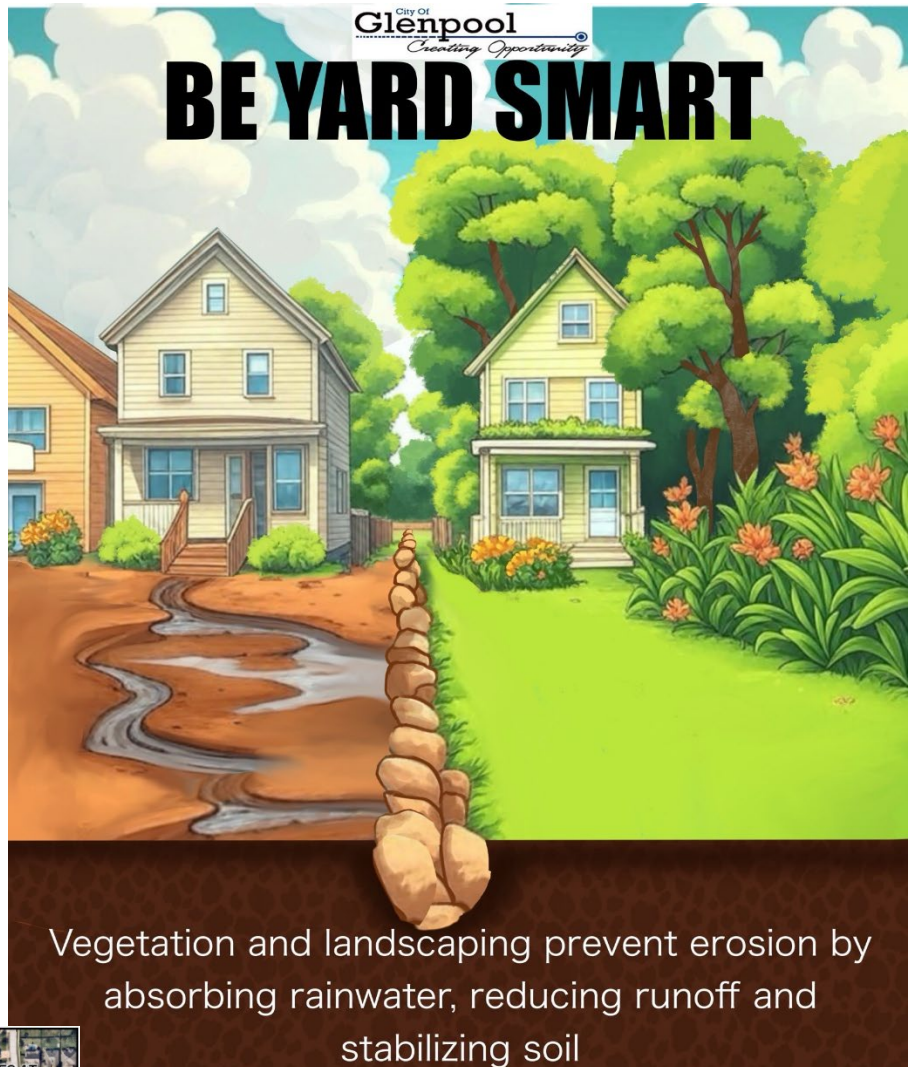

TextMyGov Launch:

On March 27th, the City launched a new communication tool, TextMyGov, designed to enhance the way we share important information with our residents. The service enables residents to effortlessly receive city notifications and access key information by simply texting the city.

Residents received an introductory message from the number 91896, which initiated the service. At any point, residents can choose to opt out by replying "STOP." Those who did not receive the initial message still have

the opportunity to opt in by texting the keyword “GLENPOOL” to 91896. After sending the keyword, users will receive a prompt to confirm participation by replying “YES.” Once enrolled, residents will begin receiving notifications for a range of topics including city events, water line repairs, road closures, meetings, emergencies, and other important updates.

In addition to alerts, residents can access information on demand 24/7 by texting 1–2 keywords to Glenpool’s TextMyGov number at (918) 880-2228. This feature allows users to obtain quick answers about potholes, streetlights, code enforcement, utility questions, and other city-related services.

The introduction of TextMyGov represents another step forward in Glenpool’s ongoing effort to deliver efficient, modern services that meet the needs of our community. This initiative reflects our commitment to implementing 21st-century solutions and improving the way we connect with residents. Many local governments across the country have adopted this platform with great success, and we look forward to seeing similar results in Glenpool. We are confident that this tool will strengthen our communication efforts and help ensure residents stay informed and engaged.

Conference Center

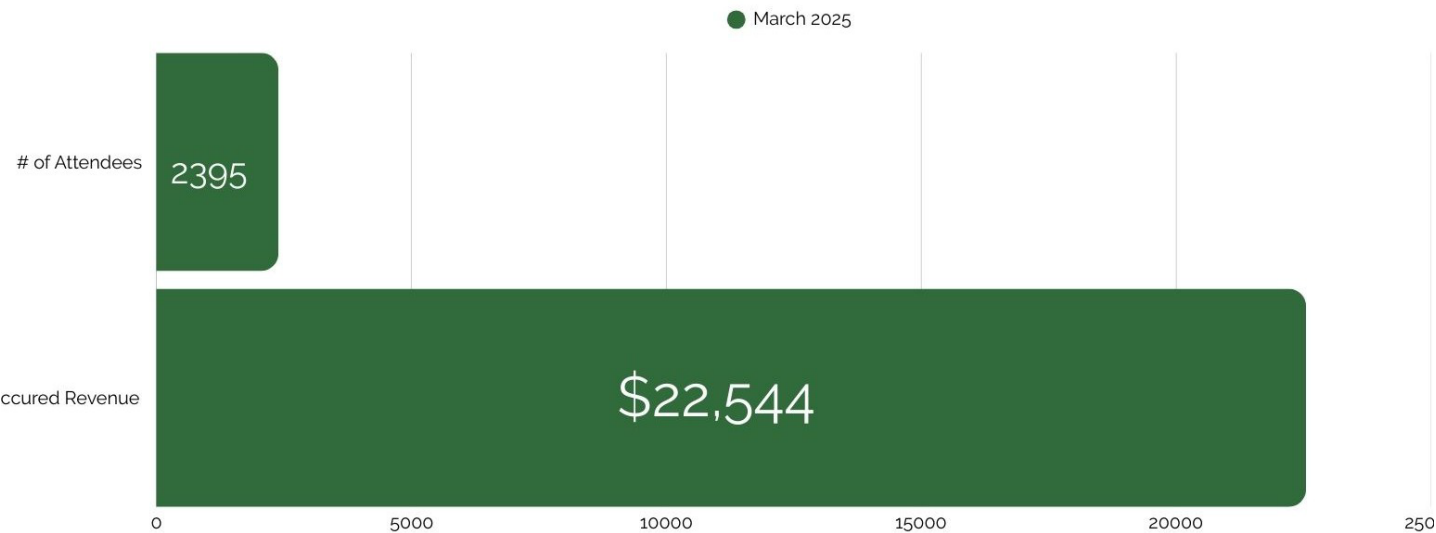

One of the standout events this month was Immense Memories scrapbooking, which returned with another highly successful Wicked-Themed Crop. Due to its popularity, the organizers are already planning another event later this year.

Additionally, we welcomed Midwest Dental Seminar, which hosted its first Compliance Summit at our venue. This conference covered critical topics such as OSHA, HIPAA, and ethics, featuring keynote speakers and attracting dental professionals from across the region.

With another busy month behind us, we look forward to continuing to provide a premier event space for a wide variety of gatherings.





Economic Development/Grants

Economic Development

- Business, Retention, & Expansion (BR&E)
 - **Morning BREW:** The Glenpool Chamber of Commerce, in partnership with the Economic Development Department and Keller Williams, hosts monthly gatherings for local businesses, offering coffee, networking, and valuable resources. On March 20, we welcomed 24 attendees. Based on feedback from our January Morning Brew, we invited Lylah Sparks from East Central Electric to share best practices for marketing and advertising.
- Oklahoma Innovation Expansion & Other Commerce Incentives
 - I have been meeting with qualifying Glenpool businesses to share information about the **Oklahoma Innovation Expansion Program (OIEP)**, which opens for applications on **March 31st** and closes on **April 11th**. These visits aim to help businesses prepare and increase the number of awardees this year.
 - I am also conducting follow-up visits with some businesses to provide additional support.
 - Beyond OIEP, I have shared the Incentive Analysis Tool from the Commerce Department to help businesses identify incentives that may better support their long-term growth and capital investment.
 - On March 31st, I will follow up with qualifying businesses to remind them of the short application window and help as needed. On March 31st, I will be following up with our qualifying businesses to remind them of the short window and aid as needed.
- New Business/Sites
 - Followed up with a landowner to discuss marketing strategies for his property and the necessary documents.
 - Met with an out-of-state developer who owns property in Glenpool. We discussed utility needs, his questions for our engineer, potential business matches for his site, and ways we can support his development efforts.
 - Engaged with brokers who have property for sale or lease in Glenpool to assess interest levels and explore how we can assist, such as posting listings on LocateOK.
 - Hosted a follow-up meeting with a Commerce Department representative to discuss BRE best practices, business incentives, land development strategies, infrastructure and utility considerations, grant opportunities, and tribal/community partnerships.
 - We are working with the broker of a potential buyer for the Blue Compass site for potential new business.
- Travel/Training/Misc:
 - We have reviewed several economic development tools to determine the best fit for business recruitment, site selection and development, real-time tourism and hospitality

data, small business support, and competitive analysis. We are now in the final stages of selecting a tool that will best support our efforts.

- On March 6, Economic Development and our Planning Team met with a firm specializing in data center site selection. As data centers continue to be a hot topic in Oklahoma, this meeting provided valuable insights for our team.
- On March 7, the Chief Operations Officer & I participated in Select Oklahoma's Day at the Capitol, where we heard from legislators who had authored economic development bills. Discussions covered key trends, concerns, and legislative priorities, and we had the opportunity to meet with our local representatives.
- On March 24, I toured the MidAmerica Business Park in Pryor, OK. MidAmerica is a national site, and I learned valuable insights on leveraging local and federal resources to drive economic development.
- On March 27, I attended Tulsa's Future Monthly Meeting in Collinsville, where we received updates on regional projects, legislative developments, and economic highlights from Collinsville. This meeting also provided a platform for local communities to share updates on their economic initiatives.
- On March 28, the City Planner and I had a TEAMS meeting with a real estate representative solely focused on Data Centers. We discussed the potential for Glenpool and what activity is occurring in our region.
- On March 28, I participated in the Tulsa Regional Chamber Aerospace Council Meeting to stay informed on developments in the aerospace sector.

Grants: March 2025, Beth Miller (Grants – Special Projects Coordinator)

- STBG street widening grant (for Elwood) awarded last year from ODOT. The signed contract was received on 1/7/2025 and on 1/13/25, David A. met with developers. Awaiting bid process as of 3/31/2025.
- INCOG CDBG Grant approved on 12/2/2024 to repair sinkhole at 145th and Kendalwood BLVD. Signatures were received from City and from County. Awaiting bid process as of 3/31/2025.
- OK Homeland Security State and Local Cybersecurity Program grant was approved 12/20/24. Able to replace the server at the PD by March or April 2025. Funds on hold by FEMA until further notice as of 3/31/2025.
- OK Homeland Security State and Local Cybersecurity Grant Program – next cycle due 2/28/25. Presented to Council the week of 2/24, declined 3/14/2025.
- FY 2025-2026 Transportation Alternatives & FY 2022-2026 CRP. up to \$1,600,000 (20% matching), Application in collaboration with David A. was submitted on 1/13/25, for completing sidewalk projects on Elwood and 141st, and Peoria Ave. Approved on 3/21/2025.
- Recreational Trails Program Grant 2025: 80% reimbursed up to \$300,000, with a total amount of \$375,000. This is for trails/parking lot/bridges at the new Morris Park Disc Golf and Nature Trails Park. Awaiting approval as of 3/31/2025.
- Opioid Grant 2025: Amount not specified. Next meeting with Mercy Mission II in April. Applications have not opened yet as of 3/31/2025, and projects are currently under discussion.

- DEQ - Collection Event Grant FY26: Application submitted February 28, 2025. Awaiting approval as of 3/31/2025.
- SAFE Oklahoma Grant: Amount not specified. We are working with GPD for equipment. Applications open in April 2025, and we are identifying the equipment needed.
- Keep Oklahoma Beautiful Roadside and Environmental Beautification grants were submitted on 1/27/25 in the amounts of \$3391.98 (for Welcome sign beautification) and \$962.45 (for seeds at Lambert Park). Grant approved in the amount of \$3700 on 2/26/2025, and check received 3/7/2025.
- AARP Community Challenge Grant submitted 3/5/25 in the amount of \$22,250.00 for a crosswalk with lights on 141st. Awaiting approval as of 3/31/2025.
- INCOG STBG FY 26 & 27 submitted March 14th: Three different projects in order of importance:
 1. Elwood Avenue Widening Phase II (Construction of 141st and 151st intersections) in the amount of \$4,946,169.
 2. Elwood Avenue Widening Phase III (Construction between 151st and 137th St.) in the amount of \$8,690,30.00.
 3. Elwood Avenue Widening Phase IV (Design of 137th – 121st St.) in the amount of \$500,000.00
- FEMA Flood Mitigation Program Grant due March 14th. 75/25 match up to 2 million. Notice of Intent (to apply) was submitted through the FEMA.GO portal on Jan. 31st for \$1,597,362. This was rescinded by FEMA until further notice.
- OCEA grant submitted February 20th (was due 2/21) for \$808.98 Welcome Sign Beautification on HWY75/S Waco. Grant was declined 3/26/2025.

Special Projects:

- Farmers Market
 - Have received 54 RSVP's for the Vendor Meeting this Sunday as of 3/31/2025.

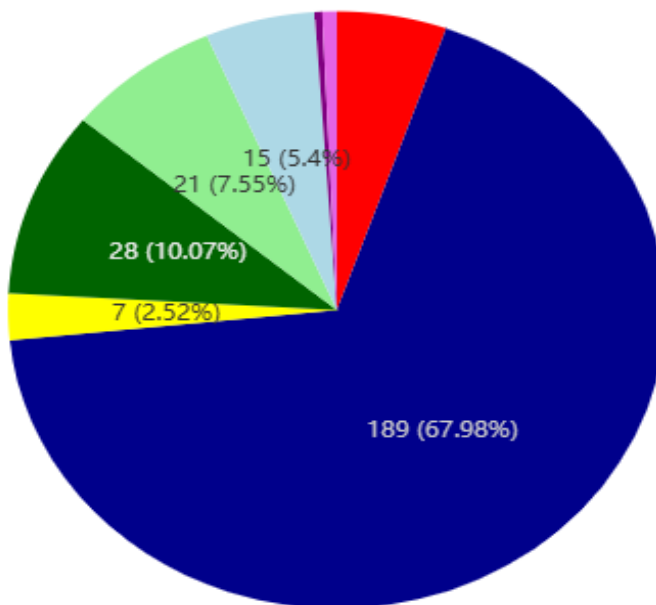
