# Executive Summary

Mayor and Council,

On the cover of this month's report is a picture from the monthly Morning Brew event hosted by the Glenpool Chamber of Commerce. This is a great event for local businesses and other chamber members to network and catch up on business opportunities across the City. Roast House Coffee always does a great job of hosting the event. The Chamber will also be hosting their annual BlackGold Christmas at BlackGold Park. The event will kick-off with the lights-on ceremony on Sunday, December 7<sup>th</sup> and will run through the end of the year. I am excited to see all the amazing trees decorated by our area businesses. This year, the City will be adding to our normal park lights and trees decorations by adding a 26-foot tree with decorations as a centerpiece of the event. Thanks to our Chief Operating Officer Lea Ann Reed for coordinating the tree and decorations. I also want to say thanks to the City's Economic Development Manager, Chad Coomer, for his work to secure a number of large Christmas decorations for the park and the event. I believe the decorations and signature tree will be a huge draw for the Chamber's event.

As you review the following departmental reports, I hope you take notice of the number of different projects that have been completed or are in progress. Allow me to take a moment and highlight a few of those that are in the report and add a few others that I believe are informative.

- I want to give a huge shoutout to Hugg and Hall Equipment Company. They stepped up and allowed the Glenpool Optimist Club host the annual BlackGold Car Show at their site when the club experienced a scheduling conflict with their original host.
- I also have to say great job to our Public Works team, as they were once again nominated for an award from Keep Oklahoma Beautiful as part of their Environmental Excellence Award Ceremony. While we didn't win this year, the team was well represented at the event.
- Staff has received the Hwy 75/67 interchange study from ODOT. We will be evaluating it over the next few weeks and will share our findings and recommended next steps to continue safety improvements along the Hwy 67 corridor.
- Sales tax moderated this month after last month's decrease. While we are still down for the year slightly, we are much closer to our estimates.
- We met with Poe and Associates in November to kick off the design phase of the Elwood Widening Project. I am very excited to see this project move forward as it is part of our Move Glenpool Forward program. Funding for the project is coming from federal transportation grants with match funds from Move Glenpool Forward.
- Glenpool Schools Superintendent Curtis Layton recently shared some statistics with his Board. I wanted to take a moment and highlight two of these numbers that stood out to me:
  - GPS had a graduation rate of 98.9%!
  - 76.3% of Glenpool graduates earned post-secondary credit hours during their time with GPS.



This is significantly better than the Oklahoma State average of 50.7%.

GPS continues to do good things in our community, and the new buildings and equipment afforded by the recent bond election will continue to strengthen the school system and provide even more opportunities for our students to prepare for their future.




# Finance

## SALES TAX

FY 25-26 Combined Sales Tax for all funds in November totaled \$1,104,537, 4.5% higher than FY 24-25 revenues for the same period. Further details on November financial results will be reported next month after the accounting period is closed.




**Sales Tax Revenue by Month**

## GENERAL FUND REVENUES

FY 25-26 General Fund revenues through October totaled \$5,502,235, which is \$53,043, or 1.0%, less than FY 24-25 revenues through the same period. Revenues were 0.6% below budget through October, with Sales Tax lagging behind budget 3.7% year-to-date.



## GENERAL FUND EXPENDITURES

FY 25-26 General Fund expenditures through October totaled \$5,379,399. This is \$397,359 higher than FY 24-25 expenditures through the same period, but \$517,138 below budget year-to-date.





## SALES TAX REVENUES—ALL FUNDS




FY25-26 Sales Tax collections through October were 3.7% below budget, and 2.2% below FY24-25 collections.

**FY 25-26 Actual Compared to Previous 3 Fiscal Years Actual**







# Development Services

Listed below are current development related activities within the City of Glenpool **through the month of November 2025**. These activities listed include Projects Under Construction, Planning Applications Under Review, Approved Projects Not Under Construction, Building Permits and Inspections, as well as Code Enforcement Activity. The most recent activities are highlighted in **red**.

## Commercial/Industrial Projects Under Construction:

1. **C & C Office Complex** – A proposed 2,672 sf office building located 459 E 151<sup>st</sup> S. The existing single-family residence will be converted into an office building.
2. **Brown Veterinary Clinic – S75 Business Park** – A proposed Veterinary Clinic located at 16161 South Broadway St. within the South 75 Business Park.
3. **Align Sport & Spine** - A proposed 6,632 sf chiropractic clinic located at 12155 South Yukon Ave.
4. **Phoenix Industrial** – A proposed 6,000 sf covered storage area within an existing industrial manufacturing business located at 18340 US Highway 75.
5. **Same Day Auto Repair** - Site plan amendment to add 14 new parking stalls and additional landscaping. The site is approximately 1.5 acres and is located at 14952 South Broadway Street West.

A. **151-75 Crossing Planned Unit Development** – A proposed Planned Unit Development (PUD 45) for a mixed-use development consisting of light industrial and commercial uses. The subject site is 76.6-acres in size and is located on the southwest corner of US Highway 75 and State Highway 67.

1. **The Lakes at Twin Mounds** – A Preliminary Plat to subdivide a 94.0918-acre site into two-hundred

and fifty-one (251) lots in nine (9) blocks and seven (7) reserve areas. The subject site is generally located on the south side of W 161<sup>st</sup> S and west of US75.

The subject site is generally located on the west side of South Elwood Avenue, approximately a quarter mile north of East 151st Street South.
4. **Scissortail 2 Phase 1** – A Final Plat to subdivide an approximately 40.20-acre site into one-hundred and eleven (111) residential lots and four (4) reserve areas. The subject site is located east of E. 148<sup>th</sup> St. S and north of S. Poplar St.

## Road Repair Projects


3 Angels Construction has begun the repair process at two separate sites in town. 147<sup>th</sup> between College and the dead end to the east. This road is scheduled to be milled and overlaid and is mostly

complete at the time of this report. The second site is 137<sup>th</sup> Pl and Nyssa Pl.. This site will receive a full depth repair with the installation of a french drain to remove the ever present ground water from beneath the surface. All areas should be complete by November 26, 2025.



## Stormwater Management

## GIS Water and Sewer Lines

## Rolling Meadows Stormwater

This project aims to address surface water runoff issues affecting residents of

Rolling Meadows near Taylor's Pond Subdivision. Crafton, Tull & Associates is the engineer of records.

- Currently at 90% plans.
- Conducted a subsurface and Utility Exploration for the interim solution for nuisance water in this subdivision.
- Finalizing supplemental contract language with the designer.



## Bicycle/ Pedestrian Masterplan Update

This is an update to the City of Glenpool's Bicycle and Pedestrian plan, which would become part of the INCOG Regional Go Masterplan. 

## SH 67 Stormwater Report

- Staff conducted a reconnaissance inspection of the stormwater infrastructure along SH-67 and observed several potential issues, including failing pipes, erosion, and possible undermining around existing structures.
- The estimated cost to replace a driveway -culvert range from \$5,000 to \$20,000, depending on pipe specifications, length, end treatments, and the required pavement replacement.
- Routine maintenance activities, such as desilting culverts, repairing eroded areas, and stabilizing channels, are relatively inexpensive and help prolong performance.
- With proper maintenance, many culvert materials can achieve a useful life of 30 years or more before full replacement is necessary.



## Community Development Block Grant

- FY2024 grant: \$120,143 for Glen Village Addition II improvements (stormwater, sinkhole, and street repairs).
- Next step: Develop design and specifications.


# Conference Center/Public Relations

## Economic Development

### Business, Retention, & Expansion (BR&E):

- The Glenpool Chamber, with support from the City of Glenpool and Curtis Evans of the Brian Frere Team – Keller Williams Realty, invites local business leaders to join us for the **November Morning BREW on Wednesday, November 20, from 7:30–9:00 a.m. at Roast House Coffee**. Come enjoy coffee, connection, and casual conversation with fellow professionals.

- The Glenpool Economic Development Team is dedicated to fostering strong relationships with local businesses and supporting long-term economic growth through a formal Business Retention and Expansion (BRE) program.
  - Comprising local, regional, and state partners, the committee meets monthly to conduct structured business visits.
  - On November 18th, we hosted a *Workforce Opportunity Luncheon* facilitated by Green Country Workforce. Seven local companies were represented, with 20 attendees in total, including members of our Economic Development team. The event was held from 11:30 AM to 1:30 PM at the Glenpool Conference Center, with lunch provided by OG&E, courtesy of Tammy Taylor, OG&E Community Affairs Manager. The workshop offered a brief but impactful overview of workforce programs available to support employers, including fully funded internship opportunities, 50% wage reimbursement for on-the-job training, and customized pipelines of emerging talent. These programs are supported through the Workforce Innovation and Opportunity Act (WIOA) and provide valuable tools to help businesses strengthen and expand their workforce.

### New Business/Sites

- Housing Study – The contract with Catalyst Commercial, along with the objectives and scope of the study, is scheduled to be presented to the City Council at the December GIA meeting for review, discussion, and approval.
- Five potential sites that could be a fit for light to medium industrial use have been submitted for internal review of water and sewer. They have already been assessed for capacity by our gas and electric utility providers, helping to evaluate site readiness and potential for future development.
- Visited applicable businesses along 141st Street to present information on the opportunity to display their business logos on interstate wayfinding signs through Interstate Logos. Provided details on the application process and potential implementation with ODOT.
- The Glenpool City Leadership Team and I visited a new Glenpool business, **Walk Your Plans** at 548 W. 125th Pl. South. The company provides a full-scale projection studio that allows clients to walk through their blueprints before construction, helping identify potential design issues and adjust early. We met the owners and received a demonstration of this innovative service.

- The COO and I met with a business owner to discuss potential relocation sites in Glenpool, connected him with another resource to assist in finding the right location, and plan to follow up on the sites discussed.
- RFP (Request for Proposal) Submissions – To date in 2025, we have received 71 RFPs through Tulsa's Future and submitted 3.

#### Travel/Training/Misc:

On 11/6, I participated in a webinar on sports and entertainment projects, focusing on strategies for funding, financing, and maximizing community benefits, as well as examples of successful venue developments.

- On 11/7, I participated in the All in for Oklahoma call with area economic developers, hosted by the Oklahoma Department of Commerce and moderated by Ernst & Young to support development of the state's economic development strategic plan.
- On 11/20, I plan to attend the State of the City event, featuring Tulsa Mayor Monroe Nichols' keynote and a moderate conversation, providing insights into the city's accomplishments, key priorities, and collaborative strategies for 2026.
- On 11/20, I also plan to attend Tulsa's *Future EDO Roundtable* at the Tulsa Chamber to review current projects, discuss the regional compact, plan next year's marketing trips, and recognize **Joe Wuest**. This group highly respects Joe and will honor him as he transitions to a new opportunity.

##### Grants Summary November 2025

- Oklahoma Transportation Alternatives Program (TAP) 2026 – Call to Projects is due 12/31/2025, grant due 1/31/26. Meeting with Matt VanAuken with INCOG on November 19<sup>th</sup> to discuss projects:
  1. Sidewalks complete 146<sup>th</sup> from Elwood to Fern and on Elwood from 146<sup>th</sup> to 141<sup>st</sup> (2<sup>nd</sup> portion will need to be discussed with ODOT to combine with STBG project)
  2. 141<sup>st</sup> Street sidewalk from Hwy 75 going west to S. Zenith St.
  3. Added in the signalization of 151<sup>st</sup> and Warrior Road (Nov 12)
- Big Beautiful Bill Funding for CLEAR Program and GrayKey License – Initial application – to be on consent agenda for a future council meeting to apply in the amount of \$28,812.28. This is a reimbursement grant. Application guidance and deadlines have not yet been released. Attending release seminar 10/27/25.
- JAG-LLE (reimbursable) Grant for Bullet Proof Vests for PD approved to apply at the October 6<sup>th</sup> council meeting. This grant is due November 2<sup>nd</sup> and was submitted on that date for \$9683.15.
- The Bureau of Justice Assistance just opened a Bullet Proof Vest program due December 19, 2025. This is on the Dec 1 council agenda for authorization to apply and will propose purchasing 5 additional vests for PD. This is a 50/50 reimbursement grant. Each vest is \$2252.80 with a total of \$11,264.00 with a reimbursable amount of \$5632.00.
- MRDAF (Municipal Road Drilling Activity Fund) approved to sign resolution for the application on 10/6/2025 and had applied 9/30/25 for \$500,000 (25% match) for repairs of 131<sup>st</sup> Street (cannot be for engineering). The total cost is 759,847.85 with a city match of \$259,847.85. Awaiting approval or decline as of 11/18/2025.
- 2024 STBG street widening grant (for Elwood) awarded last year from ODOT in the amount of \$677,160. The signed contract was received on 1/7/2025 and on 1/13/25, now awaiting finalization of contracts with Poe. Notice to proceed expected November 2025.

- INCOG CDBG Grant was approved on 12/2/2024 to repair sinkholes at 145<sup>th</sup> and Kendalwood BLVD in the amount of \$120,143. Signatures were received from City and from the County on 2/14/2025. The scope of the project changed in April, and an extension contract was signed on July 7<sup>th</sup> and returned from INCOG with county signatures on July 14<sup>th</sup>. Bid advertisements were delayed until November 2025. [23 - Agreement Renewal - INCOG - Glenpool CMF# 20251428 \(1\)](#)
- FY 2025-2026 Transportation Alternatives & FY 2022-2026 CRP. \$1,500,974 awarded with a 20% match. Application submitted on 1/13/25 for completing sidewalk projects on Elwood and 141<sup>st</sup>, and Peoria Ave. Approved on 3/19/2025. Awaiting contracts from ODOT as of 11/18/2025.
- Recreational Trails Program Grant 2025 submitted 1/31/2025: 80% reimbursed up to \$300,000, with a total project cost of \$564,188.83. Grant declined on 8/17/2025. The next deadline for this grant is January 2026. Applications open and will proceed to get on the January council agenda to apply.


